Subject:- Payment of Dearness Allowance to Haryana Government Employees continuing to draw their pay in the pre-revised pay scale as per 5th Pay Commission w.e.f. 01.07.2019.

Sir/Madam,

I have been directed to invite reference to Finance Department circular No. 4/1/2009-5FR/8996 dated 29th May, 2019 on the subject noted above and to say that the Governor of Haryana is pleased to enhance the rate of Dearness Allowance admissible to employees of Haryana Government who continue to draw their pay in the pre-revised pay scale as per 5th Pay Commission from the existing rate of 295% to 312% of the basic pay w.e.f. 1st July, 2019.

2. The additional instalment of Dearness Allowance payable under these orders shall be paid in cash to all Haryana Government employees with the salary for the month of 02/2020 payable in 03/2020.
3. The payment of arrears of enhanced Dearness Allowance for the months from July, 2019 to January, 2020 shall be made in the month of March, 2020.
4. The provisions contained in Para 3, 4, 5 & 6 in FD's instructions dated 12-01-2009 shall continue to be applicable while regulating Dearness Allowance under these instructions
