I have been directed to draw your kind attention towards the subject noted above. In this regard, it is informed that the Finance Department Instruction dated 9.4.2010 wherein it was clarified that if an employee's drawing pay in ACP scale at the time of his promotion shall not be given increment and only difference of Grade pay shall be allowed. These instructions came under adjudication before the Hon'ble Punjab & Haryana High court in CWP No. 3922 of 2011- Narender Pal Arya & Others V/s State of Haryana along-with other 51 number of connected cases. The Hon'ble High court quashed the above said instructions vide judgement dated 3.10.2016. LPA No. 2460 of 2017 has also been dismissed on 31.07.2018. Government has filed SLP in Hon'ble Supreme Court vide diary no. 47523 of 2C18, which was listed on 21.01.2019 and now to be listed again after four weeks. Now various COCPs, CWPs and Legal Notices are being filled by the petitioners / other employees which are coming on hearing in the Hon'ble Punjab & Haryana High Court.

Keeping in view the above circumstances AD is advised to tackle such cases in the following manner.
