Date from which payable	Rate of Dearness Relief on un-revised Pension/Family Pension
(i) 01.01.2018	139% to 142% 3%) of Pension / Family Pension.
(ii) 01.07.2018	142% to 148% (6%) of Pension/ Family Pension
(iii) 01.01.2019	148% to 154% (6%) of Pension/Family Pension

2. All other conditions for payment of Dearness Relief to Pensioners/Family Pensioners on un-revised Pension/Family Pension contained in referred instructions No.2/51/08-1 Pension, dated 17.04.2009, shall be applicable.
