The Governor of Haryana is pleased to promote Smt./Shri, Satyavir Singh, Anoop Singh, Chhabil Dass, Satnam Singh, Sewa Singh, Dalbir Singh and Ram Kuwar from the post of Assistant Superintendents Treasury (AST) to Assistant Treasury Officer (ATO) in the pay matrix level 7 (Seven) as per 7<sup>th</sup> Pay Commission with effect from the dates (s) they assume the charge of their new assignment.

2. They will have to qualify the departmental examination in the prescribed number of chances as laid down in the Haryana Finance Department, Treasuries (Group-B) Service Rules, 1980 applicable to them.

3. Under the provisions of Rule-10 of Haryana Finance Department, Treasuries (Group-B) Service Rules, 1980, they will be on probation for a period of one year.

4. The promotion of these officers is subject to the condition that nothing adverse regarding their integrity is recorded in their awaited ACRs. If, any adverse remarks is found in their awaited ACRs, they will be reverted back without any notice.

5. The seniority of the above mentioned newly promoted ATOs will be maintained as per current seniority in the AST cadre and will give way to their seniors in gradation list as and when the said seniors are cleared for promotion.


