Sir/Madam,

Kindly refer to this Department's memo No. 2/2/2019-1Pension (FD) dated **08.02.2021** wherein, it was decided by the State Government that a pilot may be conducted **in the following districts** for submission of Fresh Pension Cases in Online Diary Management System (ODMS):-

2. Gurugram
3. Panchkula
4. Chandigarh

Further, it was also decided that during the pilot run the fresh pension cases may be submitted with effect from **15.02.2021** both through **Online Diary Management System (ODMS) as well as in physical form.**






