**Subject:-** Regarding settlement of pending issues of pension.

Sir/Madam,

I am directed to invite your attention towards instructions issued vide letter No. 8/29/2006-4 Pension dated 30.03.2010 vide which it was decided that all the Pension Sanctioning Authorities be directed to ensure submission of all pension cases to Accountant General (A&E), Haryana alongwith option of the retirees who wish to get fixed Medical Allowances alongwith pension papers so that no litigation may arise in this respect in future.

Also as informed by Principal Accountant General (A&E), Haryana, most of the Pension Sanctioning Authorities are not adhering to the instructions issued in the above mentioned letter and are not sending the option of the retirees along with pension papers, for obtaining pension outside Haryana State while forwarding the pension case to their office.


After due consideration, it has been decided that all the Pension Sanctioning Authorities be again directed to ensure that pension cases of retiree/families of deceased government employees who wish to draw pension outside Haryana may be sent to Principal Accountant General (A&E), Haryana complete in all respects alongwith option of the retiree to get fixed Medical Allowance to avoid litigation/grievances in future.

These instructions may please be brought to the notice of all the concerned for strict compliance in future.


