**Subject:- Implementation of e-PPO as pilot project.**

Sir/Madam,

Kindly refer on the subject cited above.

It has been observed that to modernize the pension disbursement mechanism, the pension payment orders (PPO) of retired Government Employees are proposed to be issued in the form of e-PPO by the Principal Accountant General (A&E) Haryana (PAG).

The case was discussed with the PAG (A&E) Haryana time & again. The process of issue of e-PPO will play a vital role for expeditious issue of PPO of retired Government Employees.


Now, after due consideration, it has been decided by State Government that a pilot may be conducted in the following three treasuries by issuing e-PPO's in respect of Government employees who fall under the jurisdiction of these treasuries w.e.f. **01.08.2019**:-

- (i) Treasury Office, Chandigarh
- (ii) Treasury Office, Panchkula
- (iii) Treasury Office, Karnal





