- 2. Your kind attention is invited toward Government instructions No. 28/12/2014-1B&C dated 23.05.2014; 28/12/2014-1B&C dated 25.01.2014 and 28/12/2014-1B&C (T&A) Dated 06-04-2021 related to implementation of e-Post system.
- 3. As per prescribed procedure in the above referred instructions, Finance Department had frozen the sanctioned strength including diminishing cadre of all the Departments on the basis of data furnished by concerned Head of Department.
- 4. During recent review of sanctioned posts in e-Posting and HRMS by Hon'ble Chief Minister Haryana it has been found that many departments have entered incorrect data, including of diminishing cadre, resulting into mismatch of data between e-Posting and HRMS related to total sanctioned strength of a Department including of field offices. It shows that Departments have not implemented the Government instruction in letter and spirit.
- In the light of these facts, it has now been decided to defreeze the e-Post data of all departments of the State to carry out correction by all Head of Departments. This facility will be available at HOD level (ECA) only. User ID/password was already shared during the implementation of e-Post. All HOD (ECA) are required to check and enter correct data related to sanctioned strength including diminishing cadre posts of their respective Department including field offices. If any alteration in the existing data/strength of any Post/Cadre is required, then concerned HOD will submit supporting documents to concerned Expenditure Controlling Branch of Finance Department, which will examine the proposal and finalize the data as per prescribed procedure issued by Government vide instruction No. 28/12/2014-1B&C dated 23.05.2014.
- 6. All HODs (ECA) are requested to complete this exercise by 15.06.2022. Thereafter Finance Department will freeze the e-Post data. For any query, Department may contact Shri Sunil Bahal, Programmer O/o Treasuries & Accounts Department and Shri Mayank Jain, Team leader O/o NIC Haryana.
