Subject:- Implementation of e-PPO.

Sir/Madam,

Kindly refer to this Department's letter No. 2/2/2019-1 Pension (FD) dated 30.07.2019 and 25.11.2019 vide which it was decided by State Government that a pilot project may be conducted in the following four treasuries by issuing e-PPO's in respect of Government employees who fall under the jurisdiction of these treasuries w.e.f. 01.08.2019:-

- (i) Treasury Office, Chandigarh
- (ii) Treasury Office, Gurugram
- (iii) Treasury Office, Karnal
- (iv) Treasury Office, Panchkula



After the successful implementation of e-PPOs in respect of above said four treasuries, now it has been decided by the State Government to extend the e-PPO issue mechanism across the State in all treasuries commencing from **01.03.2020**.

It is requested to send the report of successful implementation of issuance of e-PPOs by **31.03.2020**.




