ORDER

- The Governor of Haryana is pleased to promote S/Shri Mitlesh Kumar Gupta, Sanjay and Rakesh Kumar, Treasury Officers to the post of Senior Accounts Officers in the functional Pay Matrix Level-11 (Eleven) (Pre revised Pay scale PB 15600-39100+6000 GP) on purely temporary basis w.e.f. the date(s) they assume the charge of their new assignment.
- The promotion of above officers to the post of Senior Accounts Officers is subject to the condition that in case their integrity is found doubtful in any awaited ACRs, they will liable to be reverted without any notice.
 - The promotion shall be without prejudice to the right of his seniors.
 - Under the provision of Rule 8 of Haryana Accounts Service (Group-B) Service Rules, 1982. They will be on probation for one year which can be extended up to three years.
